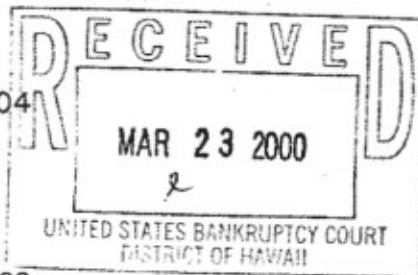

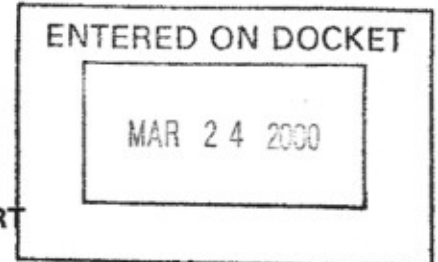

**ORDER GRANTING TRUSTEE'S  
MOTION TO APPROVE SETTLEMENT; EXHIBIT A**

The Motion to Approve Settlement Agreement ("Motion"), filed herein on February 1, 2000, by Trustee MARY LOU WOO ("Trustee"), came on for hearing on March 22, 2000. Steven Guttman appeared for the Trustee, Bradley R. Tamm and Arnold T. Phillips, II., appeared for Debtor BOBBY NORRIS HARMON ("Debtor"). The Trustee and Debtor were also present. The Motion having been reviewed by the Court together with the Memorandum in Support of the Motion to Approve Settlement Agreement and Declaration of Steven Guttman in Support of Trustee's Motion to Approve Settlement, and the records and files in the case, and the Court having considered the representations and arguments of counsel, and good cause appearing to grant the Motion,

IT IS HEREBY ORDERED that:

1. Notice given by the Trustee of the Motion is adequate and proper;
2. The Trustee's Motion is granted;
3. The Settlement Release and Indemnification Agreement ("Settlement Agreement"), a copy of which is attached hereto as Exhibit A, and each provision thereof, is approved;
4. The Trustee is authorized and directed to perform such acts as are reasonably necessary to effectuate the terms of the Settlement Agreement; and
5. The Court finds there is no just reason for delay in the implementation of this Order and this Order shall be final for all purposes, including appeal.
