Dear Mr. Tsukazaki:

I received a telephone call yesterday afternoon from Susan Tius. The purpose of Ms. Tius' call was to advise me that Bishop Estate recently received a letter from Mr. Harmon. Ms. Tius indicated that you were drafting a letter to me expressing the concerns of Bishop Estate as to communications still occurring from Mr. Harmon. I advised Ms. Tius that I was also concerned and I had thought Mr. Harmon had finally ceased his letter writing campaign.

The purpose of Mr. Tamm's call was to advise me that he had recently received a letter from Mr. Harmon. From Mr. Tamm's comments, the form of the letter he received appeared to be quite similar to the one I had received. I informed Mr. Tamm that the Bishop Estate had also recently received a letter from Mr. Harmon and that earlier in the afternoon, Ms. Tius called me concerning the letter. I told him I had not seen the letter sent to Bishop Estate and I did not mention your name


