RE: In re Bobby Norris Harmon and Thereza Zulueta Harmon, dba Orbits Hawaii, Case No. 99-04339 (U.S. Bankruptcy Court, District of Hawaii)

Although you have been receiving a continuous flow of emails from Mr. Harmon as to alleged witnesses and exhibits, the only case involving Mr. Harmon that has been pending is the above-referenced bankruptcy proceeding initiated by Mr. Harmon and his wife in 1999. This morning the Bankruptcy Clerk's office completed the processing as to case closure. Enclosed with this Memo is a notice that the Final Decree was entered on June 24, 2008, officially concluding the Harmons' bankruptcy case.

Mr. Harmon chose not to comply with various court orders and the global agreement which resolved the litigation that had been initiated prior to the 1999 bankruptcy filing. As such, the former Trustee of the Harmons' bankruptcy estate was forced to initiate legal action against Mr. Harmon, including seeking enforcement of the arbitration award issued by the American Arbitration Association. The final ruling as to Mr. Harmon's liability for ignoring the arbitration award and disobeying court orders was entered in the case captioned David C. Farmer, Successor Trustee v. Bobby N. Harmon, Case No. CV 05-00030 DAE-KSC, United States District Court for the District of Hawaii, on April 27, 2007. Mr. Harmon's appeal of certain orders entered by Judge David Ezra during the course of confirming and enforcing the arbitration award was dismissed by the 9th Circuit Court.

Many of you have requested that Mr. Harmon cease sending you emails and other communications. Although his communications were stylized as to "keeping you posted on pending litigation", as noted above there has not been any case with a pending trial date for quite some time. Further, if you had reviewed the clutter he has been sending, you would have noted that many of his communications simply set forth his personal political views and had nothing whatsoever to do with confirmation of the arbitration award or Mr. Harmon's personal bankruptcy case.

With the entry of the Final Decree in the Chapter 7 case, our firm is closing its file on Mr. & Mrs. Harmon. While there is no reason for his further communicating with us, a similar comment would be applicable to most of what he has been sending these past few years. Therefore, we will institute policies to immediately discard or delete any further communication we receive from Mr. Harmon.
